## **E13 MEMBERSHIP INFO**

Version Sept 15, 2023 | Member individuals and groups are activists, community organisers, practitioners and volunteers working across interconnected movements for - for example - migrant justice and freedom of movement, climate justice, prison abolition and transformative justice, s\*x workers' rights + mutual aid, anti-racism and queer liberation, and the many movements and issues adjacent to these. Sarj commits to try to keep at least half and ideally majority of member spots for individuals or groups primarily made up of BIPOC folks, pending of course the make-up of the application pool.

## WHAT DO MEMBERS GET?

- Use of the E13 space for up to 12 hours per month (36 hours per cycle) for their own gatherings and social equity meetups, meetings or programmes
  - This can be broken down in up to as many as 6 individual events, which should be booked on the shared calendar
  - in addition to activity hours, there is +1 hour setup/breakdown on either side of an event, to leave space for resetting the space.
  - For example, a group might host two events per month of 6 hours each; or there could be e.g. 4 events per month of 3 hours each
- Option to have one representative of the group attend the monthly advisory meetings, to give feedback to the management and help shape the future of the space
- Ability to check out or use (with prior registration) resources and equipment from the space, for example:
  - Guided use of equipment in the space (sound boxes and mixing board, microphones, projector screen, etc.)
  - Use of crafting and art supplies for events in the space
  - Checkout equipment for out-of-house events such as megaphone, awareness/Ordner vests, mobile PA system, tents and pavillions, projector and standing screen, etc.
  - Use of covid safety supplies and equipment for events in the space
    Check out books from the equity library
- Option to rearrange or customize the space to their needs, for example by re/moving the coworking table, setting up cushions and cozy lighting, pulling the curtains, hanging things on the way in a wall-safe and easily

## WHAT IS ASKED OF THE MEMBERS:

- Payment of monthly fee (5% discount given to those who pay their full amount up front), plus
- Payment of additional 100,00 € safety deposit to be paid at the start of the membership - this is regardless of what membership level you pay. In case there are no deductions needed, then this will be refunded within three weeks of the end of the cycle, should the group choose not to renew membership.
- Elect 1-2 group "Representative(s)" who are the directly responsible individuals when it comes to the membership. The representative(s) would be responsible for:
- Receive the space onboarding and share the onboarding with peers as needed
- Receive access code to enter the space via Nuki app for smartphone
- Membership in a shared Telegram group of current members
- Signing the contract for the membership, in case there is no legal entity for the group (e.g. a registered verein does not exist).
- Willingness to work with Sarj to support the membership they represent in attending to any harm that happens in the space through a communal healing process, to be defined, informed by a transformative justice ethic
- Follow COVID safety guidelines of the
- Follow mutual respect policy of the space
- Put the room back to "base" after using it
- Optional: attend monthly Advisory meeting to help inform the stewardship of the space
